Ride Amtrak Cascades to explore America's newest Car Museum, Tacoma

Tuesday, July 10 through Wednesday, July 11, 2012

This summer, America's NEWEST museum opens in TACOMA. The LeMay explores the automobile's core involvement in shaping American society. More than a century of automotive history will be spotlighted across the nine-acre campus, with the four-story, 165,000-square-foot museum the central attraction. Rotating exhibits will use cars, music, film and photos for displays such as "game-changing automotive inventions." The museum has 15 galleries that house up to 500 cars, trucks and motorcycles.

Tuesday, July 10 –AM departure on Amtrak Cascades. A box lunch will be provided. Our mid-afternoon arrival in Tacoma allows for free-time to explore art, history or glass museums. Perhaps take a walk with your tour manager across/ through Chihuly's famous Bridge of Glass.

Lodging is at the 4-star, Hotel Murano. A docent-lead tour of hotel will show us how each of the hotel's 22 floors displays a different glass artist...plus the wonderful collection in the lobby.

Dinner with a choice of entrée at The Bite Restaurant.

Wednesday, July 11 – A hot, served breakfast is provided at The Bite. We taxi to the LeMay at opening time so you have five hours to explore the museum's building and grounds. Our Amtrak Cascades departure is scheduled for 330pm so your return home will be early evening.
